

Maryhaven provides integrated behavioral healthcare services to help men, women and adolescents restore their lives from the effects of addictive and mental illness. Services include medically supervised detoxification, medication assisted treatment, long-term and short-term rehabilitation services and outpatient group, individual and family counseling. Services were provided to 7,425 patients during this reporting period.

4b (Code:) (Expenses \$ 1,529,750 including grants of \$ 564,273) (Revenue \$ 1,076,216)
Maryhaven operates the Engagement Center, an emergency shelter program, which serves chronically homeless adults with addictive and/or mental illnesses. The Engagement Center is a 50-bed facility serving both adult men and women. A total of 780 adults were served during this reporting period.

Maryhaven operates several Public Safety programs including residential driver intervention programs for adults and outpatient intervention programs to address underage drinking and drug use. A total of 1,160 persons were served during this reporting period.
