Services include supervised detoxification, medication assisted treatment, long-term and short-term rehabilitation services and outpatient group, individual and family counseling. Services were provided to 10,608 patients during this reporting period.

4b (Code:) (Expenses \$ 1,690,467 including grants of \$ 531,122) (Revenue \$ 1,941,025) Maryhaven operates the Engagement Center, an emergency shelter program which serves chronically homeless adults with addictive and/or mental illness. The Engagement Center is a 50-bed facility serving both adult men and women. A total of 714 adults were served during this reporting period.

4c (Code:) (Expenses \$ 443,858 including grants of \$ 294,428) (Revenue \$ 529,404) Maryhaven provides prevention, intervention and treatment services to individuals and families who are experiencing the effects of pathological gambling. The team also offers help to those who maybe "at risk" for becoming addicted and to adolescents who could benefit from prevention talks. A total of 154 persons were served during this reporting period.
