The Engagement Center is an emergency shelter for homeless men and women who are publicly-inebriated of the time of admission. The program provides safe shelter and attends to resident's physical and behavioral health needs. It encourages to participants to consider SUD treatment, including detoxification. Many Persons served make short, episodic use of the program. Up to 21 of the male residents and 5 of the female can remain at the Engagement Center for longer lengths of time as staff link them to other housing options as a part of the Shelter-to- Housing Program.
